

Lite Rock 107 Workplace of the Week Official Rules

CONTEST: Each week Lite Rock 107 will direct listeners to the station website at literock107.com where they can register to become the Workplace of the Week. The workplace selected will receive lunch for up to 20 people, delivered by staff from Lite Rock 107.

QUALIFICATION: Participants must locate the contest details on the station web site and click the “enter” button. From there will be asked to submit their name, address and phone number to be considered eligible for the contest. All submissions meeting the contest requirements will be entered in a random drawing for the contest prizes.

PRIZE WINNER SELECTION: Each week during the contest run one entry will be drawn at random from all eligible entries submitted. The individual on the entry selected will be named the Workplace of the Week and will receive the contest prize for that contest period. Promotions staff from Lite Rock 107 will contact the winner to make arrangements for the lunch delivery.

PRIZE: The contest prize is lunch for up to 20 people from The Corner Store in downtown Peoria delivered by personnel from Lite Rock 107. The lunch delivery will take place Wednesdays between 11:30am and Noon. The retail value of this prize will vary based on the amount of food delivered but is approximately \$8.00 a person. One contest prize will be awarded each week during this contest run. **All winners are responsible for reporting and paying taxes on prizes received.**

ODDS OF WINNING: The odds of winning will vary based on the number of contest participants.

RESTRICTIONS: Participants must be 18 years or older to be eligible to qualify for or win this contest. Contestants will be allowed one entry per person during the contest. Duplicate entries will be disregarded. Entries will carryover from week to week.

ELIGIBILITY: Employees and immediate family members and household members of JMP Radio Group LLC, The Corner Store and employees of all other media outlets are not eligible to enter. (The term “immediate family” includes spouses, parents, siblings, grandparents, children, grandchildren, and cohabitating significant others.) Lite Rock 107 reserves the right to disqualify any contestant who is financed, aided, encouraged or prompted by an employee or family member of any radio subsidiary within 100 miles of Peoria. Lite Rock 107 reserves the right to enforce the following: No contest winners whether they are on-air or off, shall be allowed to win more than once inside a 30 day period. Any person who has won any contest on Lite Rock 107 or household member is again eligible to win another contest only after 30 days have passed since their previous win. This includes all contests pertaining to the station. A person or household member will be allowed to register for a consecutive contest as long as the winning dates are 30 days apart. Lite Rock 107 reserves the right to disqualify any contestant if Lite Rock 107 deems the contest rules were not followed. Lite Rock 107 contests are void when and where prohibited by law.

FUFILLMENT: All prizes awarded through Lite Rock 107 are non-transferable nor may a prize be substituted at the request of a contest winner, nor may a prize be substituted for cash. The prize indicated by station personnel to be won in a contest is the only prize awarded and given only to the person who is designated as the winner. Lite Rock 107 reserves the right to substitute a prize of equal or greater value in the event specified prize offered is unavailable. All prizes awarded by Lite Rock 107 must be claimed within 30 days of the date the prize was won. If a winner does not claim his/her prize within the 30 day period, the prize is forfeited and eligibility restrictions mentioned in these rules still apply to that winner for future contests. Winners receiving a check as a contest prize must cash the check within 120 days from the date of issue. All checks will be voided after 120 days from the date of issue and can not be reissued. All prizes designated for pick up at the Lite Rock 107 studios must be picked up during regular business hours at 331 Fulton Street, Suite 1200, Peoria, Illinois. If a prize winner forfeits a prize for any reason, the winner will be required to sign a release to that effect and will have no further claim to the prize. In the event of that situation, the prize remains in possession of Lite Rock 107 and may be awarded to another participant at the sole discretion of Lite Rock 107.

RELEASE: Lite Rock 107 and / or sponsor participating in a contest on Lite Rock 107 may require a release form to be completed by the winner.
